Resolution to adopt Local Law No. 1 of 2011

WHEREAS, a resolution was duly adopted by the Town Board of the Town of Afton for a public hearing to be held by said Board on April 14, 2011, to hear all interested parties on a proposed Local Law No. 1 for 2011 which would repeal Local Law No. 3 of 2010 (known as the Town of Afton Road Preservation Law); and

WHEREAS, the notice of the public hearing was duly advertised in the Tri Town News, the official newspaper of the Town, on April 7, 2011 and posted at the Town Clerk's office; and

WHEREAS, the public hearing was duly held at 105 Main Street, Afton, NY at 7 p.m. on April 14, 2011, and all parties in attendance were permitted an opportunity to speak on behalf or in opposition to said proposed Local Law, or any part thereof: and

WHEREAS, the Town Board has determined that, pursuant to 6 NYCRR }617.2, the proposed adoption of Local Law No. 1 for 2011 in not an action under the New York State Environmental Quality Review Act (SEQRA) and therefore no environmental review is required in connection with the proposed adoption; and

WHEREAS, the Town Board of the Town of Afton, after due deliberation, finds it in the best interest of the Town to adopt Local Law No. 1 of 2011, thereby repealing Local Law No. 3 of 2010 in its entirety,

NOW, THEREFORE, the Town Board of the Town of Afton Hereby adopts Local Law No. 1 of 2011, a copy of which is attached hereto and made a part hereof, and the Town Clerk is Directed to enter said Local Law in the minutes of this meeting ND in the Local Law Book of the Town of Afton, and to give notice of the adoption of said local law to the Secretary of State.
