RESOLUTION

WHEREAS, the Town Board of the Town of Afton has determined that it is necessary for the Town to construct a new Town Hall for the safety of its residents and the necessary expansion of the facilities; and

WHEREAS, the Town Board has determined that the IVCI Building and Land located at 209 County Road 39 (tax Map No. 289-3-7.1) in the Town of Afton may be suitable for the construction of a new Town Hall;
