- 5) Highway Report L Shultis reports that the fuel tank has been moved to the Highway garage site. Continuing to mow with the boom mower around town. The NYS contract for salt has finally been released and has begun being mixed with sand and piled for winter usage. New Loader has arrived. 8 hour days will return on October

- 15, 2014. L Shultis requested that the Seasonal Roads notice and Mail Box notices be placed in the Tri Town. Town Clerk will do as soon as possible.
- 6) DCO Report distributed. Also requested signs are put up at front and back of Town Hall stating that people need to clean up after their dogs and it is a law and tickets and fines can be issued for failure to comply.
- 7) Animal Response Team report distributed.
- 8) Building Report In response to the questions submitted in the August board meeting by the Afton Vision Group the board offered the following.

This is a very good deal for a building of its age and condition. There approximately 5 acres of property that lends itself to future rental of both outside space and a very good selection of office suites inside. There are 6 rentable offices inside, when not rented the heating system can zone them out. We would be able to provide space for our Historian (State mandated).

This is an opportunity to provide our Court officers with a <u>safe</u> and adequate work environment. Our Court Judge and clerks do a great job for the Town and Village and its appropriate and necessary that we provide them with a safe working environment.

The agreement that we have reached is \$295,000 down from \$395,000 for the IVCI building and the 5 acres of land. They will accept ownership of the existing Town Hall and credit \$30,000 for this property making the price now \$265,000.

Renovations are still under review by May range from \$65,000 to \$95000.

Operating costs are difficult to know but we fully expect them not to exceed our present costs and once we get office rentals going, it should provide revenue for the Town.

Maintenance on this building is not a factor for a long time, unlike the buildings we occupy now. This is an opportunity for the Town to protect itself from the maintenance cost of older buildings, and making access possible for handicapped persons.

This will be put up for permissive referendum.

Time line estimate is December 2014 through February 2015.

Architect is being paid for by Gran t Monies and was appointed by board motion.
